## ORDER NO. 26 FINDING MANDATORY BASIS FOR ATTORNEY WITHDRAWAL

On July 23, 2015, Richard Jaffe, the attorney representing Stanislaw R. Burzynski, M.D., (Respondent), filed a motion to withdraw from this case. Mr. Jaffe provided no reason for his request to withdraw. On August 7, 2015, Dan Cogdell filed a motion to substitute requesting permission to serve as Respondent's counsel. On August 27, 2015, the Administrative Law Judges convened a prehearing conference with Mr. Bukstein and Mr. Cogdell appearing in person, and Mr. Jaffe appearing by telephone. During the prehearing conference Mr. Jaffe represented that under Rule 1.15 of Texas Rules of Professional Conduct he must withdraw as Respondent's counsel, and requested an *in camera* hearing before another ALJ to determine whether the Professional Rules require him to withdraw.

ALJ Suzanne Marshall conducted the *in camera* hearing and determined that pursuant to Rule 1.15, Mr. Jaffe's continued representation of Dr. Buzynski would violate the mandatory withdrawal provisions of Rule 1.15.

Accordingly, Mr. Jaffe's request to withdraw as Respondent's attorney is GRANTED.
